 - ➢ GST * (if applicable)
 - Aadhar* of authorized individual / company
 - Ownership Document*
 - Self Declaration Form*
- After submission of application form, Applicant will get an email with unique application request number, which can be used for tracking application status at various levels.
- Online submitted application form will be scrutinized in various steps viz..., Verification, Field feasibility inspection, etc. for EE, SE and CE Approval.
- After verification of the request, the applicant will receive an email with the link for payment of initial fees which includes Connection charges, Security Deposit, Road cutting, Laying Pipe line Charges, Drilling and Tapping charges etc.,
- > Applicant shall pay the fee through online using unique Application Request Number.
